BIG BEAR 4th of JULY FUN RUN July 4, 2020

In addition to implementing actions and best practices mandated by governing authorities and local health and safety experts, Big Bear 4th of July Fun Run is taking the following steps to ensure the safety and wellbeing of everyone attending a Big Bear 4th of July Fun Run event.

Cleaning and Sanitization

- 1. Reduced touch points to minimize physical interaction among all racers, and between racers and event staff.
- 2. Additional cleaning and sanitization of touch-points throughout the event area, including check-in areas, toilets, medal and shirt collection, results, payment collection points, and at aid station.
- 3. Hand sanitizer will be available for use at event site.
- 4. The aid station will use either sealed, bottled water or water will be poured, on demand, from a water cooler into a cup and placed individually on a table for pickup by runners. Runners may pick up a water bottle or cup one at a time. If a line forms, each person must stand at least 6 feet apart and wait their turn to approach the table.
- 5. Increased safety and hygiene procedures for staff and volunteers including regular hand sanitization and wearing face coverings.

Personal Protective Equipment

- 1. All event staff and volunteers will wear face coverings at all times.
- 2. Runners will be directed to wear a face covering in the event start/finish area and if passing by another runner.

Social Distancing

- 1. Runners will arrive on a rolling basis between **6:30AM-9AM**. There will be no group start, each runner will start one-at-a-time or along with those of the same household only.
- 2. Runners will be directed to run at least 10 feet away from other runners (or a household of runners) while on the course, including passing other runners.
- 3. Timing will use bibs with chips to record each runner's start and finish time.
- 4. Throughput will be monitored to ensure the number of people within the event space is kept to acceptable levels at all times.
- 5. Dedicated lanes, along with designated waiting spots, will be provided at areas where racers tend to congregate, such as at check-in. Where lines are formed, distancing markers will be used to ensure safe distancing.
- 6. Runners may not congregate after finishing the race. Please exit the event area expeditiously to allow for enough space for the next finishing runners. Event staff will keep the area clear.

Virtual Option

- 1. An option to participate virtually from in/around your own home is available to everyone.
- 2. Shirts and medals will be mailed no later than 1 week after race day, if registration is received no later than June 26. Orders after June 26 may incur a small delay. Register early to receive your swag as soon as possible!
- 3. Virtual bibs will be available for download prior to July 4.
- 4. Virtual runners are encouraged to dress up and run in their patriotic costumes/flair to be eligible for prizes in our costume contest! Upload your photos of you running in your costume to Instagram using the hashtag #July4inBigBear to enter. Prizes will be mailed to the winners.

Event Adjustments

- 1. No spectators will be permitted, unless a participating minor is being accompanied by a parent or guardian (in the start/finish area only). If you're traveling with family members that are not participating, we suggest they spend their time in Meadow Park and enjoy the views of the lake while you are running.
- 2. No awards ceremony will be held after the race to prevent gathering and ensure social distancing measures are adhered to. Awards will be mailed, however finishers will each receive their medal on-site.
- 3. Shade tents will not be provided to facilitate social distancing.
- 4. Very limited refreshments will be served. Any food items will be individually wrapped. Runners are encouraged to bring their own snacks.
- 5. Participants are highly encouraged to bring and carry their own water via bottle, hydration belt, or hydration pack. Water will be available on-site and will be served by 1 volunteer only. Please expect that you may need to wait to access the water and will need to follow social distancing while waiting in line.

Waiver

1. Each customer shall be required to sign an updated event waiver. (See full waiver below)

At Risk Persons

Anyone who falls under or lives with someone in these categories is encouraged not to participate in Big Bear 4th of July Fun Run events at this time:

- People over 65 years of age
- People who have chronic lung disease, moderate to severe asthma, or severe heart disease;
- People who are immunocompromised: those who have undergone or are undergoing cancer treatment, bone
 marrow or organ transplantation; anyone with immune deficiencies, poorly controlled HIV or AIDS, or had
 prolonged use of corticosteroids; and smokers;
- People of any age with class III or severe obesity; or
- Anyone diagnosed with the following underlying conditions: diabetes, liver disease, and persons with chronic kidney disease undergoing dialysis.

Event Waiver

I wish to participate in one or more race(s) included in The Big Bear 4th of July Fun Run.

I verify that I have full knowledge of the rigors and risk involved in participation in the Event(s), including the physical challenge of the long distance runs I have chosen, and I understand that running can be a dangerous sport. I am voluntarily participating in the Event(s) with knowledge of the dangers involved, including without limitation, the risks of death, disability, injury, loss, damages, the unavailability of medical care, or the NEGLIGENCE or deliberate act of another person and I agree to accept any and all risks of injury, damage or death. I understand that by participating in the Event(s), I will be using public streets and facilities where many hazards exist, and I am aware of and appreciate the risks which may result from my use of those streets and facilities. I am also aware that accidents or illness can occur during road and/or trail running and that I may be seriously injured or killed as a result.

I am capable of participating in the Event(s). If I am aware of or under treatment for any physical infirmity, ailment or illness, or if I am taking any prescription or over-the-counter medications, my medical care provider knows of and has approved my participation in the Event(s). I understand, or will educate myself about, the dangers of dehydration and hyponatremia (low blood sodium) and will take precautionary measures to prevent these conditions. I acknowledge that I am solely responsible for my personal health and safety, and the personal property I bring with me. I also acknowledge full and sole responsibility for my own medical expenses, and I am responsible for any and all medical expenses incurred on my behalf. If I should become injured while participating in the Event(s), I authorize the Company or Event(s) organizers to secure medical assistance on my behalf and at my expense. I will not enter and participate unless I am medically able and properly trained, and by my signature, I certify that I am medically able to perform this event, and am in good health, and I am properly trained.

I assume all risks including: the effects of the weather; high heat and/or humidity; freezing cold temperatures; traffic and the conditions of the road and/or trail including surrounding terrain. I further agree to abide by the Center for Disease Control's (CDC) recommendations for the prevention of the spread of the 2019 Novel Coronavirus Disease (COVID-19) and other communicable diseases, and I attest to having read the CDC's guidance at: https://www.cdc.gov/coronavirus/2019-ncov/prepare/prevention.html. I assume all such risks being known, appreciated, and accepted by me.

I understand that, in the event that any one or more of the provisions contained in this Waiver and Release of Liability shall, for any reason, be held to be invalid, void, illegal or unenforceable in any respect, such invalidity, voidness, illegality or unenforceability shall not affect any other provision of this Waiver and Release of Liability, and the remaining portions shall remain in full force.

I will not participate in a virtual event unless I am medically able and properly trained, and by my signature, I certify that I am medically able to perform this event, and am in good health, and I am properly trained. I further agree to abide by the Center for Disease Control's (CDC) recommendations for the prevention of the spread of the 2019 Novel Coronavirus Disease (COVID-19) and other communicable diseases,

and I attest to having read the CDC's guidance at: https://www.cdc.gov/coronavirus/2019-ncov/prepare/prevention.html. I attest that if my community has a shelter in place order, that I will only participate in the virtual event by using a personal treadmill, and I will not run outside in the community during the duration of a shelter in place order.
